# SUPURBAN RUN

5K Run & 1 Mile Fun Run / Walk

Saturday, October 17<sup>th</sup>, 2015 | Tamaqua, PA | 9:00 A.M

LOCATION/INFO: The Tamaqua Area School District Sports Complex located at 500 Penn Street Tamaqua, PA 18252. Registration / number pickup opens at 8:00 a.m. 5k starts at 9:00 A.M. with the one mile walk beginning at 9:15. Event t-shirts will be provided to those who register by September 14<sup>th</sup>. Additional shirts can be purchased for \$20. Clock at finish, refreshments, mile splits, instant results. Rain or shine. No refunds or mailed awards.

COURSE: Run will begin at the TASD Sports Complex and continue through the town of Tamaqua; running Broad Street. The course will circle the town and have participants return to the high school via Stadium Hill.

ENTRY: Cost is \$25 if postmarked by Monday, September 14<sup>th</sup>, 2015. Applications that are postmarked by September 14<sup>th</sup> will be guaranteed a shirt in the size of their choice. Cost is \$30 for all applications postmarked after September 14<sup>th</sup>; extra shirts will be given on a first come first serve basis.

DIRECTIONS FROM SOUTH OF TAMAQUA: Take 309 North into Tamaqua. At the first traffic light, (Rite Aid will be on your right) make a left onto Spruce Street. Go through one traffic light...Continue straight...Make a left at the 3rd stop sign. The stadium will be directly in front of you.

DIRECTIONS FROM EAST OF TAMAQUA: Take 209 North into Tamaqua. As you enter Tamaqua, make your first right. (Our Family Mini Mart will be on your left). Go to the top of the hill. The stadium is on your right, the high school is directly in front of you and the middle school and athletic center are to the right of the high school to be used as parking.

This waiver extends to all claims of every kind or nature what so ever, foreseen or unforeseen, known or unknown.
